

Weekly Analysis

June 14, 2025

Ohio Law initial claims, representing newly unemployed persons, totaled 5,770 last week, a decrease of 14.7 percent from the prior week's figure of 6,765 and a 2.6 percent decrease from the June 2024 weekly average of 5,925. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 15. Pandemic Unemployment Compensation (PUA) initial claims totaled zero .

Ohio Law continued claims, representing persons unemployed one week or more, totaled 48,853 last week, an increase of 2.3 percent from the prior week's figure of 47,757 and a 18.6 percent increase from the June 2024 weekly average of 41,200. Continued claims under Title 5 totaled 166. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 3 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
