

Weekly Analysis

June 21, 2025

Ohio Law initial claims, representing newly unemployed persons, totaled 4,908 last week, a decrease of 14.9 percent from the prior week's figure of 5,770 and a 17.2 percent decrease from the June 2024 weekly average of 5,925. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 17. Pandemic Unemployment Compensation (PUA) initial claims totaled zero .

Ohio Law continued claims, representing persons unemployed one week or more, totaled 49,036 last week, an increase of 0.4 percent from the prior week's figure of 48,853 and a 19.0 percent increase from the June 2024 weekly average of 41,200. Continued claims under Title 5 totaled 161. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled zero while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
