

Weekly Analysis

June 28, 2025

Ohio Law initial claims, representing newly unemployed persons, totaled 5,264 last week, an increase of 7.3 percent from the prior week's figure of 4,908 and a 11.2 percent decrease from the June 2024 weekly average of 5,925. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 20. Pandemic Unemployment Compensation (PUA) initial claims totaled zero .

Ohio Law continued claims, representing persons unemployed one week or more, totaled 49,489 last week, an increase of 0.9 percent from the prior week's figure of 49,036 and a 20.1 percent increase from the June 2024 weekly average of 41,200. Continued claims under Title 5 totaled 190. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 2 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
